## **SPORTS APPLICATION FORM**

Clubs from the area normally covered by Surrey Playing Fields (SPF) may nominate a talented sports person on an elite pathway, who would benefit from an SPF Grant to cover the essential costs associated with training or competing in their chosen sport, which would not otherwise be affordable. Except in exceptional circumstances, applicants should be aged between 10 and 20 years old. Grants will not exceed £250. The bursary scheme is subject to the funds being available.

SPF intends that a decision concerning the outcome of the application will normally be made within 4 weeks of an electronic receipt of the application.
